TERMS OF USE FOR THE MIFID II WEBSITE ("Website")

This Website and the MIFID Access Service are owned, operated and provided by BGC Technology Support Services Limited whose registered office is situated at 5 Churchill Place, London E14 5RD and is established under the laws of England & Wales, with registered number 06977673 ("We", "Us", or "Our"). These Terms of Use ("Terms") apply to MIFID Access Service only.

You should read these Terms carefully before using the Website and accessing Our Delayed Access Service. By pressing the 'acceptance button', Your electronic signature will be legally binding upon You and the organisation for whom you act, You will be deemed to have signed these Terms with the same effect as if You had signed them manually. If You do not agree to be bound by these Terms, You must not use, or should discontinue use of, the Website and/or Our MIFID Access Service immediately.

"You" "Your" shall mean: a natural person who has registered their details to use Our MIFID Access Service and where the context requires any organisation for whom such person acts.

You represent and warrant that you are duly authorised by all necessary action to: (i) execute these Terms on behalf of the organisation for whom you act; and (ii) bind such organisation to these Terms, as applicable.

1. USE OF THE WEBSITE AND THE MIFID ACCESS SERVICES

- 1.1. Subject to these Terms We will allow You access to and use of the Website and the MIFID Access Service.
- 1.2. You are expressly prohibited from using the Website, MIFID Access Service or any Data (as defined below) supplied therein, to obtain or receive, any commercial benefit (whether direct or indirect) for You, Your organisation or any other persons (individuals or entities) (the 'Restricted Purpose'). Such Restricted Purpose shall include, but shall not be limited to, the reproduction, transmission, publishing, displaying, distribution, exploitation or creation of derivative works or otherwise from Our MIFID Access Service and/or any Data therein.
- 1.3. If in Our reasonable opinion You intend to use or You are using the MIFID Access Service or any Data supplied therein for a Restricted Purpose, Your access to the MIFID Access Service may be suspended.
- 1.4. damages or losses were foreseen, foreseeable, known or We have been advised of or might have anticipated the possibility of such losses arising including:

- a) loss of actual or anticipated profits,
- b) loss of sales or business,
- c) loss of agreements or contracts,
- d) loss of anticipated savings,
- e) loss of damage to good will, or
- f) loss of use or corruption of software, data or information,
- 7.5. We, Our Affiliates and our Representatives total liability to You, Your Affiliates or any organisation with whom You are associated with or person You work on behalf of or to any other relevant third party, for any damages, losses and causes of action (whether in contract or tort, including but not limited to, negligence or breach of statutory duty) or any claim of whatsoever nature or howsoever arising, including but not limited to, in connection with these Terms or access to or usage of the Website, the MIFID Access Service or Data, shall in no event exceed GBP£5,000.
- 7.6. We may provide links to certain websites sponsored and maintained by Us or those sponsored or maintained by third parties. Such third party websites are publicly available and We are providing access to such websites through the Website solely as a convenience to You. We make no representations or warranties concerning the content of such websites or access thereto. You understand and agree that You will use or rely on such websites solely at Your own risk.
- 7.7. The terms in this clause 7 shall survive the termination of Your use of the Website and/or the MIFID Access Service.

8. TERM

- 8.1. These Terms shall commence upon Your first access to the Website and/or the MIFID Access Service and shall remain in full force and effect until access to the Website and/or the MIFID Access Service ceases or is terminated. Upon termination You shall immediately cease all usage of the Website and/or the MIFID Access Service. For the avoidance of doubt, We will revoke Your registration credentials upon termination and You will no longer be able to access the Website and/or the MIFID Access Service.
- 8.2. The termination of these Terms shall be without prejudice to and shall not affect any rights or liabilities which accrued prior to such termination.

9. PERSONAL DATA

- existence, validity or termination of the Terms) or in relation to any non-contractual obligations arising out of or in connection with them.
- 10.3. We shall not be prevented from taking such steps are we may deem necessary to enforce our rights under these Terms or otherwise (including injunctive relief) whether in England or any other jurisdiction.

11. MISCELLANEOUS

- 11.1. Any failure by Us at any time to enforce performance by You of any provision of the Terms shall in no way affect Our rights thereafter to enforce the same, nor shall the waiver by Us of any breach of any provision hereof be deemed to be a continuing waiver thereof or a waiver by Us of any other breach or any other provision hereof.
- 11.2. Any and all headings in the text of the Terms are solely for convenience or reference and do not constitute a part of the Terms, nor do they affect the meaning, construction or effect of the Terms.
- 11.3. Any time We are authorised or entitled to take any action, refrain from taking any action or make any determination, We may do so at Our sole discretion, exercised in good faith.
- 11.4. As used in the Terms, the words "include(s)" and "including" mean, "including without limitation".
- 11.5. Any representation, obligation or covenant made by You is continuous.
- 11.6. The Terms shall be construed without regard to any presumption or rule requiring construction or interpretation against the party drafting an instrument or causing any instrument to be drafted.
- 11.7. The Terms shall be binding upon You, any organisation You work for or persons on whose behalf You act.
- 11.8. A person (other than Our Affiliates), who is not a party to the Terms between You and Us, shall have no rights to enforce any of its terms.
- 11.9. You may not assign these Terms or Your access to the Website and/or the MIFID Access Service in whole or in part without Our prior written consent.
- 11.10. If any provision of the Terms is declared or found to be invalid, illegal, unenforceable or void, then:
 - a) the parties shall be relieved of all obligations arising under such provision, but only to the extent that such provision is invalid, illegal, unenforceable or void, and the Terms shall be deemed amended by modifying such provision to the extent necessary to make it valid, legal and enforceable while preserving its intent or, if that is not possible, by substituting it with another provision that is valid, legal and enforceable and achieves the same objective, and
 - b) the remaining provisions hereof shall be unimpaired and remain in full force and effect.

12. DEFINITIONS:

- 'Affiliates' shall mean: (a) in respect of Us, BGC Group, Inc. and Subsidiaries of BGC Group, Inc.; and (b) any other party to this agreement, any company, person, partnership or entity controlled by or controlling or in common control with that party. A person, company, partnership or entity shall be deemed to control another person, company, partnership or entity if the former person, company, partnership or entity possesses, directly or indirectly, the power to direct, or cause the direction of, the management and policies of the other person, company, partnership or entity whether through ownership of voting securities or partnership interests, representation on its board of directors or similar governing body, by contract or otherwise.
- 'Applicable Data Regulation' shall mean UK Data Protection Act 2018 and the UK General Data Protection Regulation as defined in the Act ("UK GDPR") The terms "processing", "personal data", "controller", "processor" and "sub-processor" bear the meanings set out in the UK GDPR.
- 'MIFID Access Service': shall mean access to data and information as required by MIFID II through Our Website which is provided in either a view only or comma separated value (csv) file format which that can be downloaded and viewed via the Website.
- **'MIFID'**: means The Markets in Financial Instruments Directive (2014/65/EU) and the Markets in Financial Instruments Regulation (MiFIR 600/2014/EU).
- **'Subsidiaries'** means, as of the relevant date of determination, with respect to any person, any other person of which 50% or more of the voting power of the outstanding voting equity securities (which, for the avoidance of doubt, shall include a general partner interest) or 50% or more of the outstanding economic equity interest is held, directly or indirectly, by such person.
